10.4	Will this proposal be evaluated solely by the buyer or by committee. If by committee, what persons or title of persons will sit on the committee?	Proposals will be evaluated by a University-designated evaluation committee composed of representatives with relevant subject-matter and institutional expertise. Specific committee members or titles will not be disclosed.
30.8	The University reserves the right to add new and similar items, by issuing a contract modification, to this contract with the consent of the vendor. Until such time as the vendor receives a contract modification, the vendor shall not accept delivery orders referencing products or services not in scope of the contract. Requests clarification	This provision allows the University, with the vendor's consent, to add similar items through a written contract modification. No products or services outside the contract scope may be provided or accepted unless a modification is fully executed.

30.14	<p>The University may undertake or award other contracts for additional or related work, services, supplies, or commodities, and the contractor shall fully cooperate with such other contractors and University employees. The contractor shall not commit or permit any act that will interfere with the performance of work by any other contractor or by University employees. Request clarification as funding proposed is dependent on exclusivity</p>	<p>This provision is intended to preserve the University's ability to meet operational needs and does not, by itself, establish exclusivity. While the University does not anticipate conflicts arising from this clause, the contract does not preclude the University from engaging other contractors for related or additional work if needed. If a vendor is proposing an exclusive arrangement, such terms must be clearly and expressly stated in the vendor's proposal and will be evaluated accordingly.</p>

This information is historical only and does not guarantee future equipment counts, placement, ownership, or configuration. Vendors should propose equipment consistent with their solution and the RFP requirements.</p>
